#### **Programme Outcomes**

# **Programme Specific Outcomes**

## (a)M.A. in Political Science Programme

The main purpose of this programme is of understanding the basic and core concepts of Political Science. It intends for the development of social and political awareness, understanding the various dimensions in the area and field of Political Science. It tries focusses on analyzing and comparing the theories of study and its utility for the society, nation and building of international relations and foreign policy dimensions. Its objective of study is understanding and evaluate the policy formulations and suggestions for better implementation. The M.A. in Political Science has core and elective papers(DSE) and Project papers also. Many students take admission into this programme through the Chancellor portal. The new CBCS revised programme was introduced 2020-22 session. The CBCS semester system earlier introduced in 2017. Through this system, it aimed to impart education both core and elective courses which are both foundational and advanced in nature and more flexible.

#### (b)PhD in Political Science

The University Department of Political Science has PhD Programme and students take admission as per regulations. There are four students have been awarded PhD degree and taken degree in the 5<sup>th</sup> Convocation ceremony of the Kolhan University on 08-04-2022. Many students have registered into PhD course and seven students have submitted their thesis. The all admissions, course works and conferment of degree is guided by the regulations. The degree is awarded to the candidate on the basis of original research work, recommended by a board of examiners and after successfully defended by the candidate during Viva-Voce. There is Department Research Council(DRC) in the Department and it monitors and decide upon all research work in the department. The University conducts PhD entrance test (PET) to take admissions into PhD programme. The candidates having MPhil and NET/JRF are exempted from PhD entrance Test. It conducts course work for taking registration into PhD programme and MPhil students are exempted from the course work. It conducts the Pre-Registration seminar and monitors all research work of the students through the DRC.

Political Science. It tries focusses on analyzing and comparing the theories of study and its utility for the society, nation and building of international relations and foreign policy dimensions. Its objective of study is understanding and evaluate the policy formulations and suggestions for better implementation.

#### **Course Outcomes**

The Choice Based Credit System (CBCS) new admission & examination regulation for PG in Political Science Courses became effective from the academic session 2020-2022. The CBCS system of semester examination was earlier introduced in 2017. The CBCS course structure for M.A., in Political Science specially designed and structured for more flexible and opportunities for students of Political Science pursuing Master Degree. As per the recommendations of UGC and NAAC for improving the quality and effectiveness of Higher Educational Institutions (HEIs) in India, Kolhan University aimed at introducing CBCS system with overall improvement in higher education system with uniformity grading system, computing the cumulative grade point average (CGPA). This semester based performance in the examinations have total four semesters with 84 credits. There are two Project Papers, one in third semester and other one is in fourth semester. In this revised new CBCS system, one more Project Viva voce was introduced in third semester. The DSE paper given more opportunities for students selecting more options in thrust area of studies.

#### Sem-1

# **CC-1-Indian Political Thought**

# **CC-2-Modern Indian Political Thought**

The purpose of this paper for introducing to students is to know and acquaint them about Modern Indian Political Thought and builders of Modern India. Its main objective is to know about Modern Indian Political thinkers and visionaries and nation builder of modern India. The special emphasis is on to know and understanding about modern Indian society, polity and nationalism. The emphasis is given to know about Political ideas and nationalism, secularism, social justice &Social exclusion, democratic rights & participation for building of modern India. The course and learning outcome will provide students some of the critical issues of Modern Indian Political thought and debate them for building of Modern India and better future.

#### CC-3-Indian Government and Politics

The students will have depth understanding on Indian Parliamentary system and government functioning.

# **CC-4-Western Political Thought**

#### Sem-3

#### CC-11, Democratic Process & Politics in India
