The sealed offer must reach to above office latest by 17th May 2018 (Up to 05.00 P.M) by registered post/speed post. The offer received after due date and time will not be accepted.
- 04) The offer should be submitted in prescribed proforma as per Annexure I alongwith a demand draft of Rs. 1000/- (Non refundable) towards cost of tender and all other relevant documents in support of eligibility and experience criteria. The draft should be drawn in favour of the Registrar, Kolhan University, Chaibasa payable at Chaibasa.

05) Scope of audit:-

It shall be the responsibility of the firm to prepare and submit fund wise Receipt & Payment A/C as well as consolidated Receipt & Payment A/C of the College and university (as applicable) alongwith report on following:-

- a) Checking and verification of cash book and bank book of each account .
- b) Checking and verification of fees/ income/receipts in each account and the review of the reconciliation of fees/income/receipts to ensure that no revenue leakage exists.
- c) Checking and verification of payment transaction to ensure that they are made as per rules of the university as well as the generally accepted accounting principles.
- d) Bank reconciliation statement of each A/c, year wise.
- e) Utilization reports and certificates of U.G.C Grants and State Govt. Grants.
- f) Statement of outstanding advances including opening balance, advances made during the year adjustment and outstanding balance at the end of the financial year.
- g) Report on stock of permanent and consumable stock.
