Details of the Provision of the following Section under Jharkhand State University act 2000 (adapted) and as ameneded upto date.

- 1. Section (18) (16)(a): Minimum of Ten teachers other than Deans, Principals and Head of University Department having at least five years teaching experience on substantive basis to be elected by and from amongs the regular teachers of the respective constituent/Govt. college in such a way the at least half of the total number of Constitutent/Govt. Colleges get representation on rotational basis based on the seniority of colleges.
 - 2. Section (18) (16)(b) : University Departments shall be represented by two elected teachers, one from Science/Commerce and other from Humanities/Social Science faculty, other than Deans and Heads of Department, having at least five years teaching experience on substantive basis.
 - 3. Section (18) (16)(c) : Permanently, affiliated colleges (other than Government Colleges) shall be represented by one elected regular teacher/Principal having at least five years teaching experience on substantive basis.

 - 5. Section (18) (20): Five persons, other than ex-officio and teacher members of the Governing Body of Colleges, shall be elected by and from amongst members of the governing bodies of the University in the manner as any be prescribed in the Statutes.
