- Goods and Services Tax if levied by the Govt. shall be payable by the colleges in addition to the Inspection Fees.
- 2. Following certificates and documents must be submitted with the proposal for
  - I. Temporary New Affiliation
  - a) Grant of formal recognition order of the proposed Institution/ College Under Section 14(3) of the NCTE Act 1993 and in accordance with latest NCTE regulation.
  - b) Undisputed ownership and possession of land as per the norms of NCTE. Provided that College running other courses also shall fulfill the norms of UGC/ State Government.
  - II. Extension of Temporary Affiliation
    - a) Compliance report of the conditions mentioned, if any, in the letter issued by State Govt./ Inspection Report of the University duly supported with documental evidences.
    - Report on the compliance of the State policy relating to eligibility criteria for the admission of students duly supported with documental evidences.
    - c) Report on the manner in which the prescribed course has been completed.
    - d) Report on conduct of the Examination.
    - e) Certificate of the AISHE registration and uploading of up to date information on AISHE portal.
    - f) Certificate that all financial transactions are done in the digital mode duly supported with documental evidences.
    - g) Certificate of accreditation by NAAC/ applied for accreditation by NAAC for colleges which has completed two Academic sessions.
