Memo : Resolutions adopted in the 12th meeting of the Academic Council is placed before the Hon'ble members for perusal and confirmation.

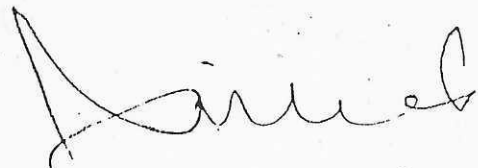
